TERMS OF THE DAMAGE PROTECTION AGREEMENT

I. COVERAGE

- A. Damage caused by accidental breakage (requires written and signed narrative report executed by the account holder).
- B. Damage caused by vandalism (requires a copy of official police or school administrator's report).
- C. Damage caused by fire, wind, or flood, or total loss (requires a copy of official report from fire department or related authority).

II. EXCLUSIONS

- A. Theft or mysterious (unexplained) disappearance of instrument outfit or any part thereof.
- B. Willful destruction of instrument, bow, case/bag, or any part thereof.

III. PROPERTY COVERED

- A. Parts of the instrument, bow, and case/bag as described below:
 - 1. External parts of the instrument consisting of the bridge, tailpiece, tailpiece hanger, endpin, string fine tuners, chinrest, and pegs.
 - 2. Body of instrument consisting of top (front), sides, back, neck, pegbox, and scroll.
 - 3. The shaft (stick) of the bow, tip plate, winding (grip), frog, screw, screw eyelet, and button.
- B. Exclusions:
 - 1. Does NOT include loss, misplacement, or mysterious disappearance of any of the external parts listed in A1 above.
 - 2. Does NOT include breakage or normal wearout of strings, bow hair, or rosin.
 - 3. Does NOT include scratches or marring of the finish (varnish) of the instrument or bow.
 - 4. Does NOT include normal wear and tear of the case/bag.

IV. REPAIR AND REPLACEMENT

- A. The instrument, bow, and case/bag will be repaired or replaced solely by and at the discretion of BROBST VIOLIN SHOP. In NO case will repair or replacement by any person or business other than Brobst Violin Shop be accepted.

V. PAYMENT OF FEES FOR COVERAGE

- A. Rental fees (including insurance fees and any late fees) must be paid to date of loss or beyond.
- B. Rental fees (including insurance fees and any late fees) which are past due will void the insurance coverage.
- C. Rental payments which do not bring account current (paid to date) will cause the insurance coverage to be void until the account is made current (paid to or beyond the due date).
- D. Payment of rental fees (including insurance fees and any late fees) which have been past due at the time of loss will not reinstate coverage for this loss.

VI. SPECIAL COVENANTS

BROBST VIOLIN SHOP reserves the right to recall an instrument outfit from rental and to cancel the rental contract at any time that excessive abuse of the instrument outfit or any of its parts has been judged to have taken place.
