TERMS OF THE RENTAL/PURCHASE AGREEMENT

The above instrument outfit is issued to the customer for rental/purchase. The monthly payment is a percentage of the total purchase price of the instrument outfit. A deposit and one month's payment are due at the time of the initiation of the rental/purchase contract. The deposit is to be refunded (interest free) in the event that the instrument outfit is returned and the contract terminated. The cost of minor repairs, if applicable, will be deducted from this deposit.

All payments apply toward the purchase price with **1% interest per month added to the unpaid balance beginning with the 7th month**. The customer may continue making payments until the instrument outfit is paid for in full or, if it is in original condition (undamaged), it can be traded in for a larger size or more expensive instrument. If the instrument is traded in during the first six months, all payments made will apply toward the larger or more expensive instrument. After six months, the instrument can be traded in but at a ___% per month reduction in its value. The instrument outfit can be returned at any time and the contract terminated with no further obligation. BROBST VIOLIN SHOP does not repurchase instruments but does accept instruments in trade for larger or more expensive instruments.

The customer agrees to assume full responsibility for the proper care and safekeeping of the instrument outfit during the rental/purchase period. Any repairs necessary for the upkeep of the instrument outfit while in the customer's possession or found to be necessary upon its return, shall be paid for by the customer. Replacement parts or components will be charged for at the current LIST price for new equipment of comparable quality. Substitute components from other sources will not be accepted. At no time shall repairs or adjustments on the instrument outfit be undertaken or performed by anyone other than a member of the firm of BROBST VIOLIN SHOP as long as this agreement remains in effect. It is also understood that this instrument outfit remains the property of BROBST VIOLIN SHOP throughout the rental/purchase period or until it has been paid for in full. The instrument outfit is not to be removed from the Washington metropolitan area during this period.

The customer is expected to pay on or before the due date of each monthly payment. A coupon book may be provided to aid the customer in making timely and accurate payments. A charge of **\$5.00** will be made each time a payment is received more than five (5) days after its above-stated due date. A **\$15.00** collection fee will be charged if a payment is 30 days or more past due and the account is placed with a collection agency. If payment is 60 days or more past due, the instrument must be returned with forfeiture of the rental deposit. An additional **\$40.00** instrument recovery fee will be charged if collection agency services are required to repossess the instrument outfit. If the account is placed with an attorney, the customer will be held liable for all collection costs, 33-1/3% attorney's fees and court costs unless contrary to law.
